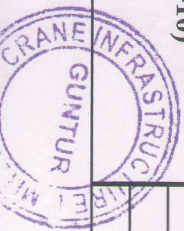

Crane Infrastructure Limited

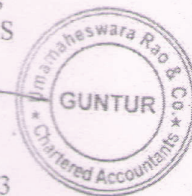
